# Do you have a weak heart? Move to Luxembourg if you want to get really good care! And get out of Rumania as quick as you can!

Brussels, July 3rd 2008

The new Euro Consumer Heart Index conclusively demonstrates that effective prevention programmes deliver a clear return on investment. Europe-wide gap is between guidelines for heart disease management and the realities of day to day clinical practice is also evident. Few countries have national screening programmes and there is widespread under-use of medication, despite well accepted guidelines.

Of the 29 countries in the Euro Consumer Heart Index, Luxembourg tops the ranking with 836 points from a possible 1,000, followed closely by France, Norway and Switzerland. The Index compares how consumer-friendly care systems are around Europe, breaking down performance into five categories, covering 28 performance indicators.

According to European Court of Justice rulings patients have the right to choose cross border care. Still the new Euro Consumer Heart Index reveals that only one country, Luxembourg, routinely permits patients to cross borders for care.

"By denying patients proper preventive care countries put patients at risk and at the same time undermine the effectiveness of their healthcare expenditure." says Dr. Arne Björnberg, Research Director for the Heart Index. "Steps like introducing national CVD screening programmes, incentivising care providers for preventive measures, smoking cessation assistance and more exercise in compulsory schools should be implemented to ensure long-term health investments."

#### What more should be done to improve delivery of heart health in Europe?

"The European Institutions are working on a directive on patient rights at cross border care, paid for by the homeland healthcare system. To many patients it will contribute to better treatments." notes the President of the Health Consumer Powerhouse, Mr. Johan Hjertqvist, analysing the Index. "No more delays for political reasons can be accepted and the proposed directive needs to be adopted as soon as possible!"

"Perhaps of even greater importance is the right to choose provider. All countries face variations in quality of care – patients need to be allowed to pick the provider they trust and knows will deliver best quality of care. In addition, by allowing consumer choice, overall standards will inevitably be improved." Mr Hjertqvist added.
